To qualify for the BRCP chapter for the National Technical Honor Society, students must hold at least a **3.0** Grade Point Average, have completed a minimum of **six (6)** high school credits in Career and Technical education coursework as well as have a **high attendance** rate. Additionally, students who hold offices in high school clubs or groups, volunteer in the **community** or for their home school will be given consideration for selection.

The BRCP National Technical Honors council consists of counselors from all five (5) Shelby County high schools, two (2) BRCP administrative staff members, and one (1) faculty/instructor member. Candidates who complete application should understand that this Student Activity Information Form is not an application for membership and that completing this form does not guarantee selection. There are a limited number of memberships each year. Priority will be given to senior students.

All candidates will receive a letter either informing them of selection or not selection. All Student Applications must be received at BRCP by **September 12, 2017**. **Late applications will not be accepted.**
