# Purchase of residential building lots

First appraisal came back at \$7,500.00 per lot. By statute, the purchase price cannot be more than ninety percent of the appraised value. Purchase price is to be \$4,000.00 per lot.

The construction trades program students will build a suitable home on the lots. Mr. Shaw feels this is a good opportunity to help improve our community and to do so using our program funds in a fiscally responsible manner.

Vince Sanders made a motion to approve the lot purchases as outlined. Travis Beck seconded the motion. The motion carried unanimously.

#### **Perkins Assessment Grant**

Steve requested approval to apply for the Perkins Assessment Grant. BRCP qualifies for \$5,010.00. The money will be used to pay for student technical assessments recognized by the DWD. Travis Beck made a motion to approve the grant application as presented. Vince Sanders seconded the motion. The motion carried unanimously.
